



Wellness Center for Older Adults Privacy Notice

The Wellness Center for Older Adults programs gather and use certain Personally Identifiable Information and Personal Health Information. This notice explains what information we collect, why we collect the information, how we use the information, how we keep the information safe, and your rights as a client of one of our programs.

Information We Collect:

The Wellness Center for Older Adults collects Personally Identifiable Information such as name, address, phone number, date of birth, emergency contact name and phone number. It also collects Personal Health Information such as medical conditions, medications, doctors' name, and phone numbers.

Why the Information is Collected:

The Wellness Center for Older Adults collects Personally Identifiable Information and Personal Health Information for three reasons: 1) to help determine eligibility for programs and services, either through our agency or another agency; 2) to help arrange programs and/or services, either through our agency or another agency; and 3) to satisfy reporting requirements for our funding agencies. Our primary funding source is the North Central Texas Council of Governments' Area Agency on Aging.

Limits on the Information We Collect, Maintain, and Make Available to Others:

The Wellness Center for Older Adults must obtain your permission before we collect, maintain, and share Personally Identifiable Information and Personal Health Information. We must get your permission, either verbally or in writing, before we make your Personally Identifiable Information available to others. We must get your written permission before we can make your Personal Health Information available to others.

Exceptions to these limitations can occur under certain circumstances, to include:

- We may share information about you to help with public health and safety issues such as:
 - Reporting suspected abuse, neglect, or domestic violence
 - Preventing or reducing a serious threat to anyone's health or safety
- We may share information about you if state or federal laws require it, including with the Department of Health and Human Services if it wants to see that we are complying with federal privacy law.
- We may share information about you to address worker's compensation, law enforcement, of other government requests such as:
 - For law enforcement purposes or with a law enforcement official
 - With health oversight agencies for activities authorized by law

- We can share health information about you in response to a court or administrative order, or in response to a subpoena.

If you give the Wellness Center for Older Adults written permission to use your Personally Identifiable Information and/or Personal Health Information, you can limit our permission. For example, you can allow us to release your information to only the individuals or entities you specify, or you can allow us to release the information to any individual or entity that might be able to help you.

WCOA's Responsibilities for Protecting Your Personally Identifiable Information and Personal Health Information:

The Wellness Center for Older Adults is required by law to safeguard your Personally Identifiable Information and Personal Health Information. We do this in several ways, to include:

- Share your Personally Identifiable Information and Personal Health Information only as you have authorized, with people who have a need to know.
- Keep your records safe from people who don't have a need to know. For example, we keep our paper records with Personally Identifiable Information and Personal Health Information in locked cabinets behind locked doors. We do not send Personally Identifiable Information and Personal Health Information through emails.

Your Rights Regarding Use of Your Personally Identifiable Information and Personal Health Information:

You have a right to review your Personally Identifiable Information and Personal Health Information which we have gathered and maintained.

If the Personally Identifiable Information and/or Personal Health Information we have is not correct, you have the right to correct any inaccurate information.

You have the right to ask questions about our privacy policies or seek clarification. You also have the right to complain if you feel that your privacy has been violated. For more information or to make a complaint, contact:
